Licencia Federativa Renewal 2021

INFORMATION ABOUT THE LICENCIA FEDERATIVA (Valencia Community Sailing Federation Licence)

(first time applicants see note 1)

******* NOTE: 2020 Annual licences EXPIRED on 31 December 2020 *******
- **irrespective of when you bought it.**

This year the renewal process has slightly changed. This is to ensure the CBYA know which members have bought a licence, and to record the licence number.

RENEWAL ORDER PROCEDURE.

- 1) Email me (natsolyn@hotmail.com) your choice of licence.
- 2) Calpe will raise an invoice and email it to you. Bank transfer details are at the foot of the invoice. Reference your transfer with the invoice number and your surname OR you can pay with cash or card in person at the office.
- 3) Once Calpe have received payment they will request the licence. You will receive an email from the FVCV (Federacion Vela Comunidad Valencia) confirming your licence.
- 4) Your licence is claimed via the SomVela mobile app.
- 5) Email me your licence number.

NOTE: THE SCHOOL DAY LICENCE is no longer available to us.

Once you have received your new licence be sure to email the licence number to me at natsolyn@hotmail.com

The licence is valid 1 January to 31 December of the issuing year.

PLEASE READ THIS CAREFULLY AS THE TYPE OF LICENCE YOU MAY NEED FOR YOUR SAILING ACTIVITY MAY HAVE CHANGED EVEN THOUGH YOU ARE DOING THE SAME SAILING.

What is the licencia Deportista?

The licence is the document that certifies us anywhere in the EU, as **members and athletes** from the world of sailing. You must have the federal licence to **participate in regattas** and will be required by the organizing Club in each competition. For **overseas regattas** you need to communicate with the FVCV in advance by 30 days in writing to licencias@somvela.com indicating the name and class of the race, the city, the country and the dates of start and end of the competition.

For all sports, it is necessary to have a **Sports Injury Insurance** covering the practice of physical activity.

You can request a **supplement** for the non-competitive Carnet Deportivo Licence (details below) for only €15 more. Then you are covered for non-competitive sailing as well as for racing.

Cruiser Racing Day - Crew Licence is available at €6/day and not be deducted from any form of subsequent license application. It enables you to compete as a crew member during a day in cruising regattas on the Valencia Sailing Federation calendar with the exception of the level 0 regattas (Copa and Spanish Championships). This licence is not valid for owners, see Day – Skipper at €20/day. The dates covered by the license will be those that appear in the application. The license will be processed for every day the race lasts. For example: individual 5 Clubs regattas are charged per regatta, the Penon Ifach Race at 3 days would be charged at 3 x per day.

What is the licencia Carnet Deportivo?

The **Carnet Deportivo** provides coverage in case of **accident insurance** and **liability** insurance for those who want to go sailing on his own **outside the field of competition**. In case of **sailing in other EU countries** it will be necessary to apply in advance to the FVCV by communicating in writing to licencias@somvela.com indicating the type of sailing, the city, the country and the dates of beginning and end of the stay abroad.

IN ANY CASE, these cards do NOT replace the nautical qualifications required for the operation of vessels according to regulations.

ACCIDENT INSURANCE

Who is covered. Annual licence holders: Deportista, Carnet Deportivo, School.

Covered risk. Accident suffered by the insured during organised competing & training.

Healthcare:

Duration: 18 months from incident.

Process: Doctors and specialists at designated centres.

Covered: Accidental injury (* in full, see SOURCE INFORMATION Certificado Seguro Accidentes).

Exclusion: Chronic and pre-existing injuries.

Cover:

Death by accident: **€6,000.**

Permanent disability according to accident scale: **€12,000.**

Unlimited healthcare in designated centre for 18 months.

Prosthesis, glasses, hearing devices, orthopedics: **€1,200.**

Death during sport but not as a direct cause of it: **€1,800.**

Funeral expenses for sports accident: **€1,500.**

Exclusions: Various, including but not limited to: chronic diseases or pathologies derived from the habitual practice of sport from repeated microtrauma; uninsurable people; accidents prior to commencement of the license; result of malicious act by the insured; if cause of accident is whilst the insured is under the influence of alcoholic beverages, toxic drugs or narcotics; (* in full, see SOURCE INFORMATION Certificado Seguro Accidentes).

CIVIL LIABILITY INSURANCE

Civil Liability Insurance **IS** included with both the Licencia Federativa Deportista and the Carnet Deportivo. It is **NOT** included with the Annual School Licence. The Civil Liability Insurance for the federated as the express coverage of claims occurred due to damage caused by the use of boats, in excess of insurance mandatory that your boat should have, even if it is not subscribed and in force.

The quantitative limit of the Guarantee is:

- Civil Liability Operation **€2,000,000**
- Sublimit per victim **€400,000**
- Excess per claim **€150**

It is NOT recommended to register independently for a licence online OR via a different Club Nautico.

1) If you apply independently for the annual race OR non-race licence the price is 90€. If there is an incident you will have to contact the FVCV yourself.

2) If you apply for a licence at a different Club Nautico any claim will have to be made through them.

A reminder that you must be a paid-up member of the CBYA (temporary or annual) to take advantage of our association with RCNC and the sailing arrangements.

Notes:

- (1) First time applications for the Licencia Federativa need to request a form from me. You will need to complete a form with your FULL NAME, NIE/PASSPORT NUMBER, DATE of BIRTH, EMAIL ADDRESS, POSTCODE in Spain and MOBILE NUMBER.
- (2) RCNC will issue you with a factura. Details for bank transfer and bank deposit are on the factura and must be paid in Euros. Please ensure any bank charges are paid by you so RCNC receives the due payment in full.
